



Duties Responsibilities and of Coach	<ol style="list-style-type: none"> 1) To Impart Coaching on the days as mentioned by CCSCSB. 2) To maintain data in a register regarding no of children/members taking coaching in a month. 3) To submit monthly report of coaching to CCSCSB. 4) Any other work as assigned to them regarding his/her individual game.
11.	Term of Engagement	<p>The coaches will be engaged initially for a period of one year extendable for a period up to 4 years. However, the Board has right to cancel the appointment for the reason to be recorded in writing at any time with the approval of CWO. After 4 years, fresh applications will be called for interview.</p>



12.	Cooling off Period	There shall be mandatory cooling off period of 2 years after every continuous appointment of 4 years.
13.	Relaxation	The Board has power to relax any of the above provision.
